#### **COMPLAINT**

The District of Columbia (the "District"), by and through the Office of the Attorney General for the District of Columbia ("OAG"), files this complaint against Hong Keun Kim,

Chung Ja Kim, Won Kyong Hwang, and SH Property Management, Inc., (collectively, "Defendants"), for violations of the Drug-, Firearm-, or Prostitution-Related Nuisance Abatement Act, D.C. Code §§ 42-3101–3114 ("Nuisance Abatement Act"). Hong Keun Kim, Chung Ja Kim, and Won Kyong Hwang jointly own the commercial property located at 3505–3511 Wheeler Road SE, Washington, D.C. 20032 (the "Property"). The Property is a commercial shopping center comprising of a liquor store, convenience store, and other stores. SH Property Management, Inc. is responsible for managing the Property. The Property is near several schools, including Eagle Academy, which is 528 feet away from the Property, and Mary Church Terrell Elementary, which is 1,056 feet away. Other nearby schools include Simon Elementary School, Hart Middle School, Somerset Prep DC, and Ballou STAY High School. Additionally, the Property is near Oxon Run Park Baseball Field and several child development and learning centers. The District requests that the Court enter an order under the Nuisance Abatement Act, requiring Defendants to abate the persistent drug and firearm nuisances at the Property. The District alleges as follows:

#### PRELIMINARY STATEMENT

- 1. The District brings this action to address Defendants' continued failure to abate the drug and firearm-related activity at the Property.
- 2. A drug or firearm-related nuisance exists where "any real property, in whole or in part, used or intended to be used to unlawfully store or otherwise keep one or more firearms...or that is used or intended to be used for the sale or manufacture of controlled substances or drug paraphernalia, that has an adverse impact on the community." D.C. Code § 42-3101(5)(B).
- 3. Here, a drug-related nuisance exists under D.C. Code § 42-3101(5)(B). The Property has been the site of ongoing drug sales. Since January 2019, the Property generated over

- 42 "Calls for Service" to the Metropolitan Police Department ("MPD") in connection to drug-related complaints. Since September 2018, there have also been at least six drug-related incidents resulting in at least six arrests.
- 4. Here, a firearm-nuisance also exists under D.C. Code § 42-3101(5)(B). The Property has been the site of ongoing firearm-related activity and gun violence over the past year. The most recent incident was a shooting on May 26, 2019 that killed a 15-year-old boy and wounded three female victims. One of the female victims was a minor. There was a string of other gun-related offenses prior to the May 26 shooting. Most notably, on October 20, 2018, MPD responded to a 911 call reporting a shooting on the Property. The victim was found on the Property with gunshot wounds and pronounced dead at the hospital.
- 5. Since January 2019, over 120 Calls for Service were generated in other related incidents, such as mayhem and disorderly conduct. These calls may also be linked to drugs and firearms.
- 6. The District brings this action pursuant to the Nuisance Abatement Act seeking "an order permanently enjoining, abating, and preventing the continuance or recurrence of the nuisance." D.C. Code § 42-3110(a). Specifically, the District seeks an order compelling Defendants to implement security measures at the Property including hiring private security personnel, installing additional remotely accessible security cameras, and repairing broken exterior lights. (*See* Ex. 1, May 13, 2019 Security Recommendations for 3509 Wheeler Road SE).

#### **Jurisdiction**

- 7. The Court has subject matter jurisdiction pursuant to D.C. Code § 11-921(a) and § 42-3102.
  - 8. The Court has personal jurisdiction pursuant to D.C. Code § 13-423(a)(5).

#### **Parties**

- 9. Plaintiff the District of Columbia, a municipal corporation empowered to sue and be sued, is the local government for the territory constituting the permanent seat of the government of the United States. The District brings this case by and through its chief legal officer, the Attorney General for the District of Columbia. The Attorney General has general charge and conduct of all legal business of the District and all suits initiated by and against the District and is responsible for upholding the public interest. D.C. Code § 1-301.81(a)(1). The Attorney General is also specifically authorized to the Nuisance Abatement Act. *See* D.C. Code § 42-3102(a).
- 10. Defendant Hong Keun Kim is a joint tenant of the 22,268 square foot shopping center located at 3505–3511 Wheeler Road SE, Washington, D.C. 20032.
  - 11. Defendant Chung Ja Kim is a joint tenant of the Property.
  - 12. Defendant Won Kyong Hwang is also a joint tenant of the Property.
  - 13. SH Property Management, Inc. manages the Property.
- 14. Charley Sung is employed by SH Property Management, Inc., and is the Property's property manager.

#### **Facts**

#### A. Notice

15. OAG sent a notice letter to Defendants Hong Keun Kim and Won Kyong Hwang advising of the presence of unlawful activity at 3509 Wheeler Road SE. That letter stated OAG

may take action against a property owner for maintaining their property in a manner that causes, creates, or maintains a nuisance as defined under the Nuisance Abatement Act and gave Defendant fourteen days to contact OAG. (See Exs. 2 and 3, April 11, 2019 Notice Letter). In response to the April 11, 2019 notice letter, Defendants contacted OAG to discuss the unlawful activity at the Property and ways the owner planned to abate the drug and firearm nuisances. OAG and Defendants also agreed to conduct a security walkthrough of the Property on May 3, 2019 with MPD. On May 3, 2019, OAG, MPD, and Defendants conducted a walkthrough of the Property and identified several security deficiencies.

- 16. On May 13, 2019, OAG sent a letter describing the shortcomings in the security measures that were observed at the walkthrough. OAG and MPD made formal recommendations for improving security and other conditions to address and prevent the persistent unlawful activity at the Property. (See Ex. 1, May 13, 2019 Security Recommendations for 3509 Wheeler Road SE). That letter requested Defendants to notify OAG in writing within fourteen days of receipt of the letter as to the status of the owners' implementation of the security recommendations.
- 17. On May 20, 2019, Charley Sung, the property manager, contacted OAG via email in response to the security recommendation letter. Mr. Sung noted that repairs were under way. Specifically, he noted that (1) the fence was repaired, and (2) he scheduled a meeting with a contractor that week to repair exterior lights, pick up litter, and cut excessive bushes and branches. He also stated that he was in the process of obtaining an estimate to resurface the parking lot. He noted that this repair could take an extended period of time if the costs were too high. Furthermore, he stated that he spoke with two tenants about hiring security personnel and installing security cameras.

- 18. On May 26, 2019, a shooting incident occurred on the Property, leaving a 15-year-old boy dead and three other female victims wounded. One of the female victims was a minor.
- 19. On May 28, 2019, OAG contacted Mr. Sung about the incident and requested updates on the security repairs. That day, he responded, stating that the fence was repaired and extended to the entrance of the parking lot. He also stated that he reminded his tenants to hire security and that he had not yet received an estimate for trash removal from the Property.
- 20. Additionally, Mr. Sung stated that both tenants assured him that their security cameras covered all areas of the shopping center and could provide passwords necessary to give MPD access to the security cameras.

#### B. Arrests

- 21. Since September 2018, MPD has made at least six arrests at the Property for several drug and firearm-related offenses, including possession of marijuana with the intent to distribute, distribution of marijuana, carrying a pistol without a license, and possession with intent to distribute a controlled substance.
- 22. On September 11, 2018, members of MPD investigated the Property and recovered 4.3 grams of marijuana, one clear plastic bag containing 33 grams of marijuana, and \$31 in US currency. As a result, members of MPD arrested one individual for Distribution of Marijuana, Possession of a Controlled Substance, and Possession with the Intent to Distribute Marijuana.
- 23. On December 29, 2018, members of MPD investigated the Property and recovered 25 small plastic bags of marijuana totaling 3.4 ounces, one small plastic bag containing 0.9 ounces of marijuana and \$135 in US currency. As a result, members of MPD arrested one individual for Possession with the Intent to Distribute Marijuana.

- 24. On January 25, 2019, members of MPD investigated the Property and recovered one black and silver Smith & Wesson Springfield 40 caliber semi-automatic handgun equipped with one round in the chamber, 56 grams of marijuana, and one digital scale. As a result, members of MPD arrested one individual for Distribution of Marijuana, Possession with the Intent to Distribute., and Carrying a Pistol Without a License.
- 25. On February 2, 2019, members of MPD investigated the Property and recovered 2.9 ounces of marijuana, one small black scale, and \$291 in US currency. As a result, members of MPD arrested one individual for Possession with the Intent to Distribute marijuana.
- 26. On February 7, 2019, members of MPD investigated the Property and recovered 1.4 ounces of marijuana, one digital scale, and \$138 in US currency. As a result, members of MPD arrested one individual for Distribution of Marijuana.
- 27. On March 5, 2019, members of the Metropolitan Police Department ("MPD") investigated the Property and recovered 59.4 grams of marijuana, one black digital scale, and \$429 in US currency. As a result, members of MPD arrested one individual Distribution of Marijuana and Possession with the Intent to Distribute Marijuana.

#### C. Calls for Service

28. Since January 2019, the Property has generated over 191 Calls for Service to MPD. At least 45 of these calls were directly linked to illegal drug and firearm-activity. (*See* Ex. 4, Calls for Service).

#### D. Reputation and Adverse Impact on Community

29. The illegal activity related to firearms in and around the Property has had an adverse impact upon the surrounding neighborhood in that:

- a. There has been an increase fear of residents to entering, existing, and passing by the Property, due to the presence, use, and display of firearms, and violence stemming therefrom. D.C. Code § 42-3101(1)(B).
- b. There has been an increased volume of vehicular and pedestrian traffic to and from the Property that is related to drug sales and use as well as the presence, use, and display of firearms. D.C. Code § 42-3101(1)(C).
- c. There has been an increase in the number of ambulance or police calls to the Property that are related to the presence, use, and display of firearms, and to violence stemming therefrom. D.C. Code § 42-3101(1)(D).
- d. There have been a number of arrests of persons on and near the Property for criminal conduct relating to the presence, use, and display of firearms, as well as the sale and use of drugs. D.C. Code § 42-3101(1)(H).
- e. There have been a substantial number of complaints made to law enforcement and other government officials about alleged illegal activity associated with the presence, use, and display of firearms in and near the Property, as well as the sale and use of drugs. D.C. Code § 42-3101(1)(J).

# COUNT I (Abatement of a Drug and Firearm Related Nuisance Pursuant to D.C. Code §§ 42-3101 to -3114)

- 30. The District hereby incorporates by reference herein Paragraphs 1 through 29.
- 31. The Property, owned and managed by Defendants, is a drug and firearm-related nuisance, as defined in D.C. Code § 42-3101(5)(B), in that it is real property "used or intended to be used to unlawfully store or otherwise keep one or more firearms...or that is used or intended to

be used for the sale or manufacture of controlled substances or drug paraphernalia, that has an adverse impact on the community."

- 32. The Property has an adverse impact on the community, as defined by D.C. Code § 42-3101(1). The adverse impact on the community caused by the drug and firearm-related nuisance at the Property is extensive and continuous, exemplified by the most recent incident that resulted in the death of a minor and injuries to multiple other victims.
- 33. Individuals in and around the Property engaged in drug and firearm nuisance activities are a consistent and serious threat to District residents.
- 34. Not only have Defendants failed to fully abate the nuisance, but they have perpetuated the issue by their inadequate action despite notice from the District.

#### REQUESTED RELIEF

**WHEREFORE**, the District of Columbia respectfully requests declaratory and injunctive relief and damages against Defendants, as follows:

- a. That the Court declares the Property owned and managed by Defendants to be a drug and firearm-related nuisance pursuant to the Drug-, Firearm-, or Prostitution-Related Nuisance Abatement Act, D.C. Code §§ 42-3101–3114;
- b. That the Court enjoins Defendants from creating and/or maintaining, or assisting in the creation or maintenance of a drug or firearm-related nuisance property;
- c. That the Court orders Defendants to immediately abate all illegal nuisances at the Property;
- d. That the Court orders Defendants to hire armed Special Police Officers to patrol and secure the Property during business hours, specifically from Monday through Sunday, 9:00 a.m. to 10:00 p.m.;

e. That the Court orders Defendants to increase number of security cameras and

provide MPD with remote access;

f. That the Court orders Defendants to repair and properly maintain all exterior lights;

g. That the Court orders Defendants to maintain the exterior of the property grounds,

including but not limited to, regular trash collection and other grounds maintenance, repaving the

parking lot, and install speed bumps at the entrance/exit of the Property;

h. That Defendants shall a) submit to the District copies of all served barring notices

currently in the possession of Defendants, and prospectively, all served barring notices within one

(1) week of issuance; and (2) provide a copy of each such notice to the District by delivering a

copy to Althea Geletka, Paralegal Specialist, Office of the Attorney General, 441 4th Street NW,

Suite 600 South, Washington, D.C. 20001;

i. That the Court award damages to be paid by Defendants in the amount of \$150 per

day since the date Defendants were provided the notice of the nuisance on April 11, 2019, to be

paid into the Drug-, Firearm-, or Prostitution-Related Nuisance Abatement Fund pursuant to D.C.

Code § 42-3111;

j. An award of costs and reasonable attorneys' fees, as authorized by D.C. Code § 42-

3110(b)(1); and

k. Such other and further relief as this Court deems just and proper.

Re: Security Recommendations for 3509 Wheeler Road SE

Mr. Sung:

The Office of the Attorney General for the District of Columbia ("OAG") is writing to follow up on our previous communications regarding the drug and firearm nuisances at 3509 Wheeler Road SE, Washington, D.C. 20020 (the "Property") which is owned by Hong Keun Kim and Wong Kyong Hwang and managed by Charley Sung. On April 11, 2019, OAG transmitted a letter giving formal notice of the drug and firearm nuisance activity at the Property. In response, you contacted OAG and agreed to conduct a security risk assessment along with the Metropolitan Police Department ("MPD") to identify security concerns and recommend further actions that should be taken to abate the nuisance activities at the Property.

On May 3, 2019, you met with OAG and MPD to conduct a walkthrough of the entire Property. Based on the property walkthrough, we identified five areas of security concerns:

- 1. Inadequate illumination (i.e., nonfunctioning exterior lighting);
- 2. Breaches around the Property (i.e., broken and missing fencing);
- 3. Lack of maintenance on property grounds (i.e., trash buildup, overgrown trees covering business signs, parking lot requires resurfacing);
- 4. Insufficient number of security cameras and lack of remote access to all cameras for MPD.
- 5. No armed security personnel.

#### Recommendation 1

Illumination is critical in curtailing the ongoing nuisance activities. There are nonfunctioning exterior lights across the Property. These exterior lights must be repaired

and properly maintained. Further, there are missing and broken lightbulbs across the Property. See Exhibit 1. These lightbulbs must be replaced, and at a minimum, high wattage lights should be installed and secured throughout the Property.

#### Recommendation 2

There was a noticeable breach along the property lines, specifically broken and missing fencing. These breaches invite individuals to loiter on your Property. OAG and MPD recommend repairing or replacing this fencing. See Exhibits 2 and 3. OAG and MPD also recommend installing fencing from the trash cans to the driveway entrance/exit. See Exhibit 4.

#### Recommendation 3

There is a lack of maintenance on property grounds that is adversely affecting safety. There is trash buildup on and around the Property. See Exhibits 5 – 7. Visible signs of neglect, like pieces of trash scattered and overflowing trash cans, exacerbate security issues because it gives the impression that nobody is watching or caring for the Property and therefore people can do whatever they want. Accordingly, all trash and debris need to be removed from the Property and disposed of in accordance with District law. There are also overgrown trees that are covering up your business sign. See Exhibit 8. These trees must be cut back and properly maintained. Furthermore, the parking lot requires resurfacing. See Exhibits 9 and 10.

#### Recommendation 4

The security cameras are currently not remotely accessible by MPD. See Exhibits 11 and 12. There are also missing security cameras facing critical locations. See Exhibits 13 and 14. A centralized security camera system that covers the entire Property must be installed. All cameras installed on the Property shall be accessible to MPD via an online web portal. In the event of an incident, MPD can promptly respond to and address the security issues.

#### Recommendation 5

Due to the significant number of drug and firearm-related arrests at your Property, OAG and MPD strongly recommend that the property owners hire at least one private security personnel during business hours, specifically from Monday through Sunday, 9:00 a.m. to 10:00 p.m. Private security personnel can respond to incidents in a timely fashion, and deter such incidents from occurring.

#### Conclusion

As explained previously, because of the number and seriousness of the complaints and incidents that MPD and the Office of the Attorney General has received about the Property, we believe the Property may constitute a drug and firearm nuisance pursuant to D.C. Code §§ 42-3101 to -3114. OAG reiterates that this law places the responsibility on

the property owner to ensure that their property is not used in a manner that is detrimental to the welfare of the surrounding area. Therefore, please notify us in writing within fourteen (14) days of receipt of this letter the status of the property owner's implementation of the security recommendations described above.

We thank you in advance for your prompt attention to these recommendations.

#### Dear Property Owner:

The Office of the Attorney General for the District of Columbia has received information that you are the owner of the commercial property located at 3509 Wheeler Road SE, Washington, D.C. 20032. I am contacting you to seek an immediate meeting with you regarding illegal activity that has been occurring at your property.

Our office received information indicating that your property was used to facilitate violations of D.C. Code § 48-901.01 *et seq.* and for the sale or manufacture of controlled substances or drug paraphernalia. Our office also received information indicating that your property was used to unlawfully store or otherwise keep one or more firearms.

On March 5, 2019, members of the Metropolitan Police Department ("MPD") investigated your property and recovered: 59.4 grams of marijuana; one (1) black digital scale; and \$429 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana and Possession with the Intent to Distribute Marijuana.

On February 7, 2019, members of MPD investigated your property and recovered: 1.4 ounces of marijuana; one (1) digital scale; and \$138 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana.

On February 2, 2019, members of MPD investigated your property and recovered: 2.9 ounces of marijuana; one (1) small black scale; and \$291 in US currency. As a result, members of MPD arrested one (1) individual for Possession with the Intent to Distribute Marijuana.

On January 25, 2019, members of MPD investigated your property and recovered: one (1) black and silver Smith & Wesson Springfield 40 caliber semi-automatic handgun equipped

with one (1) round in the chamber; 56 grams of marijuana; and one (1) digital scale. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana, Possession with the Intent to Distribute Marijuana, and Carrying a Pistol Without a License.

On December 29, 2018, members of MPD investigated your property and recovered: twenty-five (25) small plastic bags of marijuana totaling 3.4 ounces; one (1) small plastic bag containing 0.9 ounces of marijuana; and \$135 in US currency. As a result, members of MPD arrested one (1) individual for Possession with the Intent to Distribute Marijuana.

On October 20, 2018, members of MPD responded to your property for a 911 call for the "Report of a Shooting." Once on scene, members of MPD located one victim suffering from gunshot wound(s) to the body. The District of Columbia Fire and Emergency Medical Services Department ("FEMS") responded to the scene and transported the victim to a hospital where he was subsequently pronounced deceased.

On September 11, 2018, members of MPD investigated your property and recovered: 4.3 grams of marijuana; one (1) clear plastic bag containing 33 grams of marijuana; and \$31 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana, Possession of a Controlled Substance, and Possession with the Intent to Distribute Marijuana.

Copies of the police reports are attached.

Due to the seriousness of this incident, we are investigating your property as a drug nuisance pursuant to D.C. Code §§ 42-3101 to 3114. Under this D.C. law, my office may take action against a property owner who does not maintain their property in accordance with District of Columbia law and in a manner that does not cause, create or maintain nuisance. This letter is notice to you that your property may constitute a nuisance.

The law places the responsibility on the property owner to ensure that the property is not used in a manner that is detrimental to the welfare of the surrounding area. Therefore, we would like to invite you to meet with members of the Office of the Attorney General regarding the activity at your property and what steps you will take to correct it. Please contact me within fourteen (14) days of receipt of this letter. I can be reached at (202) 724-6526 or at the email address listed below. I thank you in advance for your prompt attention and response to this request.

Re: Notice of Unlawful Activity at 3509 Wheeler Road SE

Dear Property Owner:

The Office of the Attorney General for the District of Columbia has received information that you are the owner of the commercial property located at 3509 Wheeler Road SE, Washington, D.C. 20032. I am contacting you to seek an immediate meeting with you regarding illegal activity that has been occurring at your property.

Our office received information indicating that your property was used to facilitate violations of D.C. Code § 48-901.01 *et seq.* and for the sale or manufacture of controlled substances or drug paraphernalia. Our office also received information indicating that your property was used to unlawfully store or otherwise keep one or more firearms.

On March 5, 2019, members of the Metropolitan Police Department ("MPD") investigated your property and recovered: 59.4 grams of marijuana; one (1) black digital scale; and \$429 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana and Possession with the Intent to Distribute Marijuana.

On February 7, 2019, members of MPD investigated your property and recovered: 1.4 ounces of marijuana; one (1) digital scale; and \$138 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana.

On February 2, 2019, members of MPD investigated your property and recovered: 2.9 ounces of marijuana; one (1) small black scale; and \$291 in US currency. As a result, members of MPD arrested one (1) individual for Possession with the Intent to Distribute Marijuana.

On January 25, 2019, members of MPD investigated your property and recovered: one (1) black and silver Smith & Wesson Springfield 40 caliber semi-automatic handgun equipped

with one (1) round in the chamber; 56 grams of marijuana; and one (1) digital scale. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana, Possession with the Intent to Distribute Marijuana, and Carrying a Pistol Without a License.

On December 29, 2018, members of MPD investigated your property and recovered: twenty-five (25) small plastic bags of marijuana totaling 3.4 ounces; one (1) small plastic bag containing 0.9 ounces of marijuana; and \$135 in US currency. As a result, members of MPD arrested one (1) individual for Possession with the Intent to Distribute Marijuana.

On October 20, 2018, members of MPD responded to your property for a 911 call for the "Report of a Shooting." Once on scene, members of MPD located one victim suffering from gunshot wound(s) to the body. The District of Columbia Fire and Emergency Medical Services Department ("FEMS") responded to the scene and transported the victim to a hospital where he was subsequently pronounced deceased.

On September 11, 2018, members of MPD investigated your property and recovered: 4.3 grams of marijuana; one (1) clear plastic bag containing 33 grams of marijuana; and \$31 in US currency. As a result, members of MPD arrested one (1) individual for Distribution of Marijuana, Possession of a Controlled Substance, and Possession with the Intent to Distribute Marijuana.

Copies of the police reports are attached.

Due to the seriousness of this incident, we are investigating your property as a drug nuisance pursuant to D.C. Code §§ 42-3101 to 3114. Under this D.C. law, my office may take action against a property owner who does not maintain their property in accordance with District of Columbia law and in a manner that does not cause, create or maintain nuisance. This letter is notice to you that your property may constitute a nuisance.

The law places the responsibility on the property owner to ensure that the property is not used in a manner that is detrimental to the welfare of the surrounding area. Therefore, we would like to invite you to meet with members of the Office of the Attorney General regarding the activity at your property and what steps you will take to correct it. Please contact me within fourteen (14) days of receipt of this letter. I can be reached at (202) 724-6526 or at the email address listed below. I thank you in advance for your prompt attention and response to this request.

#### **INITIAL ORDER AND ADDENDUM**

Pursuant to D.C. Code § 11-906 and District of Columbia Superior Court Rule of Civil Procedure ("Super. Ct. Civ. R.") 40-I, it is hereby **ORDERED** as follows:

- (1) Effective this date, this case has assigned to the individual calendar designated below. All future filings in this case shall bear the calendar number and the judge's name beneath the case number in the caption. On filing any motion or paper related thereto, one copy (for the judge) must be delivered to the Clerk along with the original.
- (2) Within 60 days of the filing of the complaint, plaintiff must file proof of serving on each defendant: copies of the summons, the complaint, and this Initial Order and Addendum. As to any defendant for whom such proof of service has not been filed, the Complaint will be dismissed without prejudice for want of prosecution unless the time for serving the defendant has been extended as provided in Super. Ct. Civ. R. 4(m).
- (3) Within 21 days of service as described above, except as otherwise noted in Super. Ct. Civ. R. 12, each defendant must respond to the complaint by filing an answer or other responsive pleading. As to the defendant who has failed to respond, a default and judgment will be entered unless the time to respond has been extended as provided in Super. Ct. Civ. R. 55(a).
- (4) At the time and place noted below, all counsel and unrepresented parties shall appear before the assigned judge at an initial scheduling and settlement conference to discuss the possibilities of settlement and to establish a schedule for the completion of all proceedings, including, normally, either mediation, case evaluation, or arbitration. Counsel shall discuss with their clients **prior** to the conference whether the clients are agreeable to binding or non-binding arbitration. **This order is the only notice that parties and counsel will receive concerning this Conference.**
- (5) Upon advice that the date noted below is inconvenient for any party or counsel, the Quality Review Branch (202) 879-1750 may continue the Conference <u>once</u>, with the consent of all parties, to either of the two succeeding Fridays. Request must be made not less than seven business days before the scheduling conference date.

No other continuance of the conference will be granted except upon motion for good cause shown.

(6) Parties are responsible for obtaining and complying with all requirements of the General Order for Civil cases, each judge's Supplement to the General Order and the General Mediation Order. Copies of these orders are available in the Courtroom and on the Court's website <a href="http://www.dccourts.gov/">http://www.dccourts.gov/</a>.

### ADDENDUM TO INITIAL ORDER AFFECTING ALL MEDICAL MALPRACTICE CASES

In accordance with the Medical Malpractice Proceedings Act of 2006, D.C. Code § 16-2801, et seq. (2007 Winter Supp.), "[a]fter an action is filed in the court against a healthcare provider alleging medical malpractice, the court shall require the parties to enter into mediation, without discovery or, if all parties agree[,] with only limited discovery that will not interfere with the completion of mediation within 30 days of the Initial Scheduling and Settlement Conference ("ISSC"), prior to any further litigation in an effort to reach a settlement agreement. The early mediation schedule shall be included in the Scheduling Order following the ISSC. Unless all parties agree, the stay of discovery shall not be more than 30 days after the ISSC." D.C. Code § 16-2821.

To ensure compliance with this legislation, on or before the date of the ISSC, the Court will notify all attorneys and *pro se* parties of the date and time of the early mediation session and the name of the assigned mediator. Information about the early mediation date also is available over the internet at https://www:dccourts.gov/pa/. To facilitate this process, all counsel and *pro se* parties in every medical malpractice case are required to confer, jointly complete and sign an EARLY MEDIATION FORM, which must be filed no later than ten (10) calendar days prior to the ISSC. D.C. Code § 16-2825 Two separate Early Mediation Forms are available. Both forms may be obtained at www.dccourts.gov/medmalmediation. One form is to be used for early mediation with a mediator from the multi-door medical malpractice mediator roster; the second form is to be used for early mediation with a private mediator. Both forms also are available in the Multi-Door Dispute Resolution Office, Suite 2900, 410 E Street, N.W. Plaintiff's counsel is responsible for eFiling the form and is required to e-mail a courtesy copy to earlymedmal@dcsc.gov. *Pro se* Plaintiff's who elect not to eFile may file by hand in the Multi-Door Dispute Resolution Office.

A roster of medical malpractice mediators available through the Court's Multi-Door Dispute Resolution Division, with biographical information about each mediator, can be found at www.dccourts.gov/medmalmediation/mediatorprofiles. All individuals on the roster are judges or lawyers with at least 10 years of significant experience in medical malpractice litigation. D.C. Code § 16-2823(a). If the parties cannot agree on a mediator, the Court will appoint one. D.C. Code § 16-2823(b).

The following persons are required by statute to attend personally the Early Mediation Conference: (1) all parties; (2) for parties that are not individuals, a representative with settlement authority; (3) in cases involving an insurance company, a representative of the company with settlement authority; and (4) attorneys representing each party with primary responsibility for the case. D.C. Code § 16-2824.

No later than ten (10) days after the early mediation session has terminated, Plaintiff must eFile with the Court a report prepared by the mediator, including a private mediator, regarding: (1) attendance; (2) whether a settlement was reached; or, (3) if a settlement was not reached, any agreements to narrow the scope of the dispute, limit discovery, facilitate future settlement, hold another mediation session, or otherwise reduce the cost and time of trial preparation. D.C. Code§ 16-2826. Any Plaintiff who is *pro se* may elect to file the report by hand with the Civil Actions Branch. The forms to be used for early mediation reports are available at www.dccourts.gov/medmalmediation.
