**Consent to Participate in Impaired Driving Social Media Contest  
To Engage Youth in Preventing Traffic Fatalities and Discouraging  
Impaired Driving Media Grant/Release/Waiver Agreement (Agreement)**

For good and valuable consideration, including the right to participate in the Contest, the receipt and sufficiency of which is hereby acknowledged:

I, \_\_\_\_\_ (Grantor) hereby irrevocably grant, convey, and assign to the District of Columbia, including the Office of the Attorney General for the District of Columbia, the District of Columbia Department of Transportation, the District of Columbia Public Schools, and my child's charter school, if applicable (Grantees), as well as their successors, assigns, licensees, and legal representatives, the right to use my child's submission (Submission) to the *Impaired, No Time to Drive* (Contest) and/or to use my child's name, image, likeness and/or voice in a Contest Submission, and use the Submission and /or written and other work of my child in the Contest Submission, any and all manner and media, including without limitation the right to edit the Submission, and create derivative works and composite or distorted representations thereof, an unlimited number of times throughout the universe in perpetuity for any lawful purpose. I understand that my child's address, and biographical information, with the exception of my child's name, image, likeness, and/or voice, will not be made public.

I agree that the District of Columbia, acting by and through the Office of the Attorney General for the District of Columbia, shall be the exclusive owner of the results and proceeds of such use with the right to copyright, to use, and to license others to use, all or any portion or reproduction thereof, in all manner and media, an unlimited number of times throughout the universe in perpetuity; and

I hereby waive any right of inspection or approval of my child's name, image, likeness, and/or voice in the Contest Submission, and use of the Submission and /or written and other work of my child pertaining to the Contest or the uses to which such appearance or Submission may be made. I hereby release the Grantees from any and all liability associated with my and my child's participation in this activity, and I agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the rights and permissions granted in this Agreement.

I hereby release the Grantees, their employees, successors, licensees, and assignees from any and all claims, damages, liabilities, costs and expenses which I or my child now have or may hereafter have by reason of any use thereof.

I understand that the provisions of this Agreement are legally binding.
