

SETTLEMENT AGREEMENT

This Settlement Agreement (Agreement) is entered into between the District of Columbia (the District) and [REDACTED] (collectively, the Parties).

PREAMBLE

As a preamble to this Agreement, the Parties agree:

- A. WHEREAS, the District is a municipal corporation created by an Act of Congress and is the local government for the District constituting the seat of government of the United States, D.C. Code § 1-102.
- B. WHEREAS, between October 28, 2018, through November 22, 2024, [REDACTED] and her associated vehicles amassed 189 traffic citations in the District of Columbia.
- C. WHEREAS, on March 20, 2025, the District notified you in writing of its intent to pursue legal action against you to recover \$54,288 in unpaid fines, penalties, and fees associated with 189 traffic infractions (Covered Conduct) under the Strengthening Traffic Enforcement, Education, and Responsibility Amendment Act of 2024 (STEER Act), D.C. Code § 50-2201.04(g)(1) and the Delinquent Debt Recovery Act (D.C. Code § 1-350.06(6)).
- D. WHEREAS the license plates subject to this Agreement are Virginia license plate TTP8398 with 44 traffic citations issued between January 27, 2023, through July 31, 2024, and Maryland license plate 2DN4126 with 145 traffic citations issued between October 28, 2018, through January 2, 2023. All of the above referenced traffic citations subject to this Agreement are reflected in the attached eTIMS report.

- E. WHEREAS, this Agreement is not a concession by the District that its claims are not well founded, or an admission by [REDACTED] of the District's allegations.
- F. WHEREAS, to avoid delay, uncertainty, inconvenience, and expense of protracted litigation, the Parties have reached this full and final settlement agreement:

TERMS AND CONDITIONS

THEREFORE, in consideration of the mutual promises and covenants in this Agreement, the Parties agree:

1. Permanent and Binding Resolution. This Agreement is a permanent and binding accord and resolution of the rights and obligations of the Parties with respect to all matters subject to this Agreement.

2. Payment. [REDACTED] agrees to pay the District thirty thousand five hundred ninety dollars (\$30,590) (Settlement Amount). [REDACTED] shall have 60 months, or five years, to pay the Settlement Amount. Specifically, [REDACTED] shall pay monthly amounts starting on January 15, 2026, as follows:

Effective January 15, 2026, [REDACTED] shall pay \$250 every month continuing the 15th day of every month through and including December 31, 2026.

Effective January 15, 2027, [REDACTED] monthly payments shall increase by \$50 (fifty dollars) to a total of \$300 per month continuing through and including December 31, 2027.

Effective January 15, 2028, [REDACTED] monthly payments shall increase by \$50 (fifty dollars) to a total of \$350 per month through and including December 31, 2028.

Effective January 15, 2029, [REDACTED] monthly payments shall increase by \$50 (fifty dollars) to \$400 per month through and including December 31, 2029.

Effective January 15, 2030, [REDACTED] monthly payments shall increase by \$50 (fifty dollars) to a total of \$450 per month through and including December 31, 2030.

Within 30 days thereafter, or no later than January 15, 2031, [REDACTED] shall pay the remaining outstanding balance of \$9,590 (or the amount outstanding by that date) in a lump sum payment to the District.

All payments shall be made by money order, certified or cashier's check payable to the "District of Columbia Treasurer" and mailed to Valerie Deal, Civil Litigation Division, Office of the Attorney General for the District of Columbia, 400 Sixth Street, N.W., Suite 10100, Washington, D.C. 20001.

3. Required Driving Course: [REDACTED] agrees to enroll in and complete a defensive driving course offered through the District of Columbia's Department of Motor Vehicles (DMV) approved vendors within six (6) months of the signed settlement date. The defensive driving courses can be completed online through the Online Traffic School at <https://www.trafficschool.com/DC-Washington-DC/safe-driving-course/> or the American Safety Council at <https://www.safemotorist.com/district-of-columbia/defensive-driving>. [REDACTED] shall submit proof of completion of the defensive driving course to the District within thirty (30) days of the completion date.
4. Compliance with Traffic Laws. [REDACTED] agrees to abide by all District traffic and safety laws and to refrain from incurring any additional traffic citations in the District during the pendency of the Agreement. To the extent that [REDACTED] [REDACTED] incurs additional traffic citations, she agrees to respond to the citations and

comply with the Department of Motor Vehicles administrative process set forth in D.C. Code § 50-2302.05 and D.C. Code § 50-2303.05.

5. Release by the District. Subject to the terms of paragraph 6 of this Agreement and conditioned upon full payment of the Settlement Amount, the District agrees to release [REDACTED] from any and all actions, disputes, claims, and demands for damages it may have had, now has, or may have, arising out of the Covered Conduct.
6. Non-Released Claims. Notwithstanding any term of this Agreement, the District specifically does not release:
 - (a) claims or liability under federal laws, criminal laws, or the District's tax laws;
 - (b) liability under the District of Columbia False Claims Act;
 - (c) liability to the District or its agencies for conduct other than the Covered Conduct;
 - (d) liability to enforce a tax or child support obligation; and
 - (e) claims based upon obligations created by this Agreement, including claims to enforce the terms and conditions of this Agreement.
7. Legal Costs. Except as provided in paragraph 13, each party to this Agreement shall bear its own legal and other costs incurred in connection with this matter, including the preparation and performance of this Agreement.
8. Voluntary Agreement. [REDACTED] represents that she has freely and voluntarily entered this Agreement without any degree of duress or compulsion.
9. Opportunity to Confer. [REDACTED] represents that she has had the opportunity to confer with legal counsel before signing this agreement.

10. Representations. The undersigned District signatory represents that she is signing this Agreement in her official capacity and that she is authorized to execute this Agreement on behalf of the District and bind the District.
11. Governing Laws. This Agreement is governed by the laws of the District of Columbia. The Parties agree that the exclusive jurisdiction and venue for any dispute arising between the Parties under this Agreement shall be the Superior Court of the District of Columbia.
12. Entire Agreement. This Agreement constitutes the complete agreement between the Parties related to the Covered Conduct. This Agreement may not be amended except by written amendment signed by both Parties. But if any provision of this Agreement is determined by the Superior Court of the District of Columbia to be unlawful, then the District may, at its option, choose to sever such provision or declare the entire Agreement null and void.
13. Binding Agreement. This Agreement shall be binding upon the Parties and their successors, transferees, heirs, and assigns.
14. Breach. If [REDACTED] fails to make three consecutive payments under this Agreement, the District may, within ten (10) days' notice to [REDACTED], file an action for entry of a consent judgment in the full amount of [REDACTED] outstanding debt of \$54,288, less any payments made, plus attorney's fees, if this Agreement is breached.

15. Effective Date. This Agreement shall become effective upon the signature of all Parties.

16. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
